Warranty Statement

This Warranty Statement outlines the warranty terms applicable to customers who have purchased a solar solution from Genie Insights Ltd.

1. INTRODUCTION

- **1.1.** This warranty statement includes:
 - **1.1.1.** the Solar Panel (the Module);
 - **1.1.2.** any associated components making up the Solar Panel System (the System); and
 - **1.1.3.** any components making up the remainder of the solution (the Kit).
- **1.2.** This Warranty Statement sets out the terms upon which we will provide limited warranties in relation to the Modules, certain component part(s) which form part of the System, and the components making up the Kit.
- **1.3.** Subject to the terms in this Warranty Statement, in order to rely on such warranties, the Modules (and component part(s)) must be:
 - **1.3.1.** Registered with us (further details on how to register the System are set out in Clause 9 below) (Modules, once registered with us, being Registered Modules); and
 - **1.3.2.** Installed by a fully qualified and competent electrical engineer and in accordance with the installation guide provided to you by, or developed in conjunction with, Genie Insights Ltd.
- **1.4.** If a copy of the Installation Guide has not been previously provided to you, you must request one from us before commencing installation of any system. It is your responsibility to ensure that you have the most up-to-date Installation Guide before commencing any installation.

3. WARRANTY FOR THE SOLAR PANEL (The Module)

3.1. The "Warranty Period" for the purposes of this Warranty Statement shall mean the period of **5** years commencing on the date your system was installed by an approved installer or from the date of purchase, whichever is the least. It is therefore in your best interest to supply the required warranty details via the below procedure outlined in Clause 9.

3.2. THE SOLAR PANEL COMPONENT WARRANTY

3.2.1. Subject to paragraphs 3.4, 3.5 and 3.6 of this Warranty Statement, we warrant that the component parts which are manufactured by the solar panel manufacturer and which form part of your System (Component Parts) will during the Warranty Period function and will be free from defects in material and workmanship that negatively affect the functionality of the components supplied under proper installation, operation and maintenance conditions when applied in accordance with the Installation Guide.

3.3. THE SOLAR PANEL PERFORMANCE WARRANTY

- **3.3.1.** Subject to paragraphs 7.2, 7.3 and 7.4 of this Warranty Statement, we warrant that during the **Performance Warranty period of 10 years**, the Registered Modules shall produce at least 95 percent of the power output for the first two years (plus or minus specified tolerance levels); for the next three year period (years 3 through to 5 after shipment) produce at least 90% of the specified power output (plus or minus specified tolerance level); and for the next 5 years (years 6 through to 10 after shipment) produce at least 80% of the specified power output (plus or minus specified tolerance levels) The power output rating is as specified in the original order documentation.
- **3.4.** The Output Warranty will commence in line with the Warranty Period outlined in paragraph 3.1 above.
- **3.5.** The Output Warranty will only apply to the extent that the Module is installed in accordance with the Installation Guide.
- **3.6.** In the event that you bring a successful claim under the Output Warranty, we may (at our sole option) either:
 - **3.6.1.** arrange for the relevant equipment to be repaired or replaced; or
 - **3.6.2.** provide supplemental Module to meet the minimum power output; or
 - **3.6.3.** refund a prorated portion of the purchase price you paid for the System commensurate with the lost power (such amount to be determined by us acting reasonably and in good faith).

4. WARRANTY FOR THE CHARGE CONTROLLER (PART OF THE COMPONENT KIT)

4.1. We warrant that the charge controller which forms part of the Component Kit will during the Warranty Period function and will be free from defects in material and workmanship that

- negatively affect the functionality of the components supplied under proper installation, operation and maintenance conditions when applied in accordance with the Installation Guide.
- 4.2. The "Warranty Period" for the purposes of this Warranty Statement shall mean the period of **3** years commencing on the date your system was installed by an approved installer or from the date of purchase, whichever is the least. It is therefore in your best interest to supply the required warranty details via the below procedure outlined in section 9.

5. WARRANTY FOR ALL OTHER COMPONENTS MAKING UP THE KIT (ALL KIT COMPONENTS EXCLUDING THE CHARGE CONTROLLER)

- 5.1. We warrant that all components (excluding the Charge Controller) which form part of the Component Kit will during the Warranty Period function and will be free from defects in material and workmanship that negatively affect the functionality of the components supplied under proper installation, operation and maintenance conditions when applied in accordance with the Installation Guide.
- 5.2. The "Warranty Period" for the purposes of this Warranty Statement shall mean the period of **12 months** commencing on the date of purchase.

6. WARRANTY CIRCUMSTANCES

- **6.1.** The Component Warranty will commence in line with the Warranty Period outlined in paragraphs 3.1, 3.3.1, 4.2 and 5.2 above.
 - **6.1.1.** The Component Warranty will not apply in circumstances where the electrical system into which the System is integrated (including any customisation and additions)
 - **6.1.1.1.** is not appropriately protected;
 - **6.1.1.2.** is not in good condition;
 - does not comply with applicable law, regulation or industry standard in each case as determined by us (or an Approved Installer or electrician or electrical engineer (Electrical Expert) nominated by us) acting reasonably and in good faith; and/or
 - areas in which the System and/or Component Parts are installed are not appropriately protected from damage and environmental conditions (as determined by us, or an Electrical Expert nominated by us, acting reasonably and in good faith); and/or
 - **6.1.1.5.** System and/or Components Parts are subjected to any damage;
 - **6.1.1.6.** the fault with the Component Part(s) is as a result of routine wear and tear (as determined by us, or an Electrical Expert nominated by us, acting reasonably and in good faith); and/or

- **6.1.1.7.** the System and/or Components Parts are not installed in accordance with the Installation Guide; and/or
- **6.1.1.8.** the fault is a result of any defects or failures caused by any devices or parts other than the Module(s) or Component Part(s)
- **6.1.2.** The Warranty applies solely to the modules and the Component Parts and does not cover repair or replacement of:
- **6.1.2.1.** the electrical system to which the System is connected; or
- **6.1.2.2.** any additions or customisations made to your electrical system to accommodate the System.
- **6.1.3.** In the event that you make a successful claim under the Component Warranty, we shall, at our sole discretion either:-
- **6.1.3.1.** repair or replace the Component Part(s) in respect of which the claim is made; or
- **6.1.3.2.** refund such amount of the price paid for the System which relates to the Component Part in respect of which the claim is made.

7. EXCLUSIONS

- **7.1.** The Warranties outlined in paragraphs 3.1, 3.3.1, 4.2 and 5.2 shall each be a Warranty for the purposes of this Warranty Statement and shall together be referred to as the Warranties.
- **7.2.** The following exclusions, limitations and conditions apply to the Warranties.
 - **7.2.1.** Excluded Costs. We shall not be responsible for the costs of:
 - **7.2.1.1.** investigating and/or diagnosing alleged or actual problems or defects with the System, Modules (whether or not Registered Modules), Component Part(s) or Kit Components;
 - **7.2.1.2.** removing a Module (whether or not a Registered Module), the System, Component Part(s) or Kit Components requiring service, repair or replacement;
 - **7.2.1.3.** reinstalling a Module (whether or not a Registered Module), the System, Component Part(s) or Kit Components after it has been repaired;
 - **7.2.1.4.** installing a replacement Module, System, Component Part or Kit Component after we have determined pursuant to this Warranty Statement to replace it; or
 - **7.2.1.5.** transporting the Module(s) (whether or not a Registered Module), the System, Component Part(s) or Kit Components to you or the Installer.
 - **7.2.2.** Excluded Clauses. The Warranties do not cover any damage, malfunction, or failure which we determine acting reasonably and in good faith resulted from design considerations unique to particular use of the System.

- **7.2.3.** The Installer has the best knowledge of the variables affecting a particular use and is responsible for the assessment of acceptable risks and benefits. On those occasions where design decisions cause or contribute to failures or are not consistent with the instruction in the Installation Guide, the Warranties do not apply.
- **7.2.4.** Any deviation from the Installation Guide must be agreed in writing by Genie Insights Ltd in advance.
- **7.2.5.** Excluded Claims. The Warranties do not cover, and we shall not be responsible for any claim under the Warranties, where we determine acting reasonably and in good faith that that claim is as a result of:
 - **7.2.5.1.** any repair, modification, service or movement of a Module or Component Part undertaken by someone other than a person appointed by us;
 - **7.2.5.2.** any defects or failures caused by acts undertaken by or omissions by you or any third party including, but not limited to, the mounting methods used to install the Module(s), Component Parts and Kit Components;
 - **7.2.5.3.** inappropriate connections or use of Component Parts, this includes, but is not limited to:-
 - **7.2.5.3.1.** connection of the System in a manner that generates or exposes the system to inappropriate voltages;
 - **7.2.5.3.2.** failures of the System resulting from other electrical components on the vehicle on which the System is installed;
 - **7.2.5.3.3.** failures of the Module(s) caused by failed or defective system components other than the System itself; or
 - **7.2.5.3.4.** failures of the Module caused by improperly rated or defective wiring or other connections;
 - **7.2.5.3.5.** exposure of the Module to abuse, misuse, or negligent acts by you or by a person other than us, including but not limited to:
 - **7.2.5.3.5.1.** any failure to maintain the surface of the Module in accordance with the Installation Guide.
 - **7.2.5.3.5.2.** use of inappropriate abrasives or chemicals that damage the Module;
 - **7.2.5.3.5.3.** prolonged exposure to a marine environment unless the installation complies with specific guidelines applicable to such installations;
 - **7.2.5.3.5.4.** abnormal environmental conditions such as acid rain, smoke, salt damage or other pollution; or
 - **7.2.5.3.5.5.** external corrosion, mould discoloration, or the like;

- **7.2.5.3.5.6.** undue shear or torsional forces due to poor design, quality, or maintenance of the roof upon which the module is mounted;
- **7.2.5.3.5.7.** exposure to power surges, lightning, fire, flood, pest damage, accidental breakage, actions of third parties and other similar events or accidents outside our reasonable control and not arising under normal operating conditions.
- **7.3.** The Warranties do not apply if the model number or serial number on the Module, any Component Parts or Kit Components are altered, removed, defaced, or otherwise rendered illegible.
- **7.4.** The Warranties only apply in relation to Modules and Component Parts (as applicable) whilst they remain mounted on the roof at which the installer first installed the System.

8. USE OF REMANUFACTURED OR REFURBISHED PARTS

- **8.1.** We may, at our sole option, use new, remanufactured or refurbished Modules or Component Parts when repairing or replacing any Module, Component Part or Kit Component following a successful claim by you under the Warranties.
- **8.2.** Any replaced Module(s), Component Part(s) or Kit Component(s) will become our property once replacements have been installed.

9. REGISTERING YOUR SYSTEM

9.1. To register your system, please provide the installation date, installer details, vehicle details and serial numbers for your Module and Charge Controller by completing the Solar Panel Installation & Serial Number Record form at https://forms.gle/N9sVn9kKrhuqHVYt5 or by scanning the below QR code.

- **10.2.** Any representation, condition or warranty which might be implied or incorporated into this Warranty Statement by statute, common law or otherwise is excluded to the fullest extent permitted by law.

11. YOUR LEGAL RIGHTS

- 11.1. Notwithstanding the terms of paragraph 11.1 and 11.2, you have certain legal rights and remedies available to you in relation to the System, Modules, Component Parts and Kit Components. No provision of this Warranty Statement shall limit or in any way restrict any such legal rights or remedies that you may have. - **11.2.** We do not exclude or limit in any way our liability to you where it would be unlawful to do so. This includes liability for death or personal injury caused by our negligence or the negligence of our employees, agents or subcontractors, for fraud or fraudulent misrepresentation.

The maximum amount we shall be liable to account to you for (including in relation to the cost of repair or replacement of any Module, Component Part, System or Kit Component) under or in connection with this Warranty Statement shall not exceed the purchase price that you paid for the System to which this Warranty Statement relates.

14. MAKING A CLAIM

- 14.1. To make a claim under a Warranty (Warranty Claim) you must contact Genie Insights' customer services using the contact details outlined in paragraph 2.2.
- 14.2. Warranty claims must be submitted in the Warranty Period with a description of the claimed defect, the system serial number, and evidence indicating the purchase date.

15. GOVERNING LAW AND JURISDICTION

15.1. This Warranty Statement is governed by Northern Irish law and you can bring legal proceedings arising out of or in connection with this Warranty Statement in the Northern Irish courts.

16. SEVERANCE

16.1. Each of the paragraphs of this Warranty Statement operates separately. If any court or relevant authority decides that any of them are unlawful, the remaining paragraphs will remain in full force and effect.
